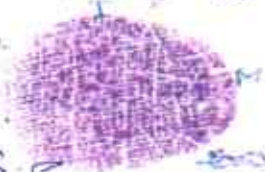
THIS DEED OF TRUST made on this 24th day of July 2003, at HIRIYUR, Chitradurga District, by

Hereinafter called the authors of the Trust (which expression shall unless excluded by or repugnant to the subject and context, and or survivor or survivors of any of them and their successor or successors in office).

WHEREAS the Authors are desirous of creating a Trust, and establishing a fund and irrevocably endowing the same, upon the Trust, for Public Charitable, education and cultural purposes, at Hiriyur, as hereinafter expressed and contained in these presents and in the name of **SRI BASAVARAJ EDUCATIONAL TRUST.**

(2) WHEREAS, It is the desire of the Authors of the Trust that the corpus of the Trust may be further augmented from time to time by flow of funds and all future additions and accretions thereto, and all such accumulated income thereof and all other property or properties movable or immovable that may be acquired out of the said funds or otherwise by way of gift or donations, acquisitions and allotments grant exchange or otherwise may hereafter by the fund/property of the Trust.

(3) WHEREAS, the above said six persons who are also authors of the Trust appointed to be Trustees for holding the said property in trust for the purpose detailed in this TRUST DEED HEREIN BELOW :

3. OBJECTS OF THE TRUST :-

The objects for which the Trust is founded are as follows :-

i. To establish promote maintain and run Schools, Medical, Paramedical and Technological Training Colleges, Nursing College, Industrial Training Centers, Orphanages and Residential Schools and allied Educational institutions to impart basic and advanced education grant scholarship and awards to deserving and needy, for promotion of education and learning, in all branches and more specifically in science and technology.

ii. To promote, set up, or maintain, clinics, hospitals, ambulances services and medical facilities and to provide aid and relief either on it own, or in association with other organisation with similar objectives.

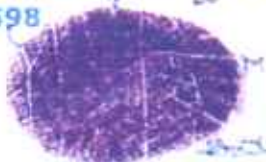
iii. To establish Old age Homes, Destitute Homes, for providing relief, help, food, shelter and clothing to the aged persons, poor and disabled free of cost.

xii. To carryout the above objects either directly or indirectly or through others or jointly with other or similar objectives, in any manner whatsoever, as decided by the Board of Trustees in keeping with the spirit of the Trust.

xiii. To function as a non communal Trust.

4. BENEFICIARIES :-

The Trust shall stand possessed of the said amount of corpus endowed by the Authors of the trust, and all such other properties - both movable and immovable, as may be acquired from time to time by the Trust, by purchase, exchange, grant, allotment, subscription, endowment, donation, contribution or in any manner whatsoever, all of which shall be designed as TRUST FUNDS AND PROPERTIES, on the Trust herein mentioned.

5. TRUSTEES - NUMBER :-

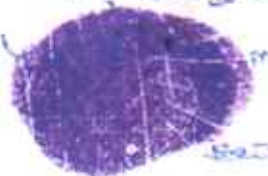
a) The number of trustees including the Authors of the Trust shall not be less than Five, and not more than 11 as the Trustees of this Trust, and they collectively constitute Board of Trustees of this Trust.

b) The Board of Trustees may in the interest of the Trust, nominate and invite one or more persons to be additional Trustee for such period, as they may deem fit and proper, apart from those mentioned in para 5 (a) above.

6. TERM OF OFFICE OF THE TRUSTEE :

i) The Author Trustees shall hold the office of Trustees for their life or until they voluntarily retire, or otherwise render themselves legally disqualified to hold such office. They may nominate their heir, to succeed them in the Trust.

9.TERMINATION OF THE OFFICE OF THE TRUSTEE :-

A Trustee shall cease to hold office :-

a)If he dies, b)if he is physically unfit, c)if he resigns d) if he is adjudged insolvent, e) found guilty of an offence involving moral turpitude. f)found to have acted against the interest of the Trust. g) upon expiry of the period up to which the Board of Trustees have nominated such a Trustee. h) if it is unanimously decided by the Trustees specified in para 6 above, that his continuation in office is against the interest of the Trust.

10. FUNCTIONARIES OF THE TRUST:-

- i. In the first meeting of the Author Trustees, A President, A Managing Trustee, A Executive Trustee, shall be chosen from among themselves for the administration of the Trust.
- ii. The term of office (duration) of these office bearers, viz., the president, the Managing Trustee and the Executive Trustee, shall also be for such period as may be specified on this behalf, in the said meeting.

- iii. The Author Trustees may, from time to time reappoint the retiring person/s or appoint any other Trustee/s; for the office of the President, Managing Trustee, and Executive Trustee, as and when the vacancy arises, and the persons so re-appointed or appointed shall hold the respective offices for such term as the Author Trustees may determine from time to time.
- iv. Any Trustee who fails to attend THREE consecutive meetings of the Board without seeking leave of absence, shall incur disqualification, and therefore cease to be a Trustee of the Board.
- v. The Author Trustees shall nominate their heir to succeed them as Trustee, and the term of the said Trustee who so succeeds, shall be for life, or till he retires, or otherwise disqualified to hold the office of Trustee.

11. FUNCTIONS AND DUTIES OF THE TRUSTEES :-

a. All property of the Trust movable or immovable or of any other kind, shall vest in the Trust. The Trustees shall manage the whole property and affairs of the Trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the Trust.

b. In particular, and without prejudice to the generality of the foregoing the Trustees shall, for the purpose of this Trust, have the following powers, duties and functions:-

i. To acquire by Gift, Grant, Purchase, Exchange, Lease, or otherwise, lands, buildings, or other immovable properties and also any movable property.

ii. To construct and maintain buildings to alter, to demolish or improve them and equip them suitably.

xi. To delegate to the Managing Trustee, Executive Trustee or any appointed committee, or a Trustee, such power, duties and functions as are vested in the trustees.

xii. To frame By-Laws and such other Regulations as are required for achieving its objectives.

xiii. Out of the income of the Trust property, the Trustees shall be entitled to spend or incur the following expenses namely.

- a) All rates, taxes, cess, assessments, dues and duties if any payable to the Government, to any Municipal or other public bodies, in respect thereof or any part thereof.

- c) The costs of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the Trust property.
- d) The cost of making such additions/alterations of improvements to or in the building forming part of the Trust property, as the Trustees shall think fit.
- e) Wages and salaries of any Manager, Supervisor, Accountant, clerk, servant or other employees employed by the Trustees in the carrying out of this Trust.
- f) Cost and expenses of keeping the Trust property in good condition.
- g) To give from out of the income of the Trust fund, scholarships, financial assistance, awards, prizes, books study material and any other assistance to the needy and deserving, public.

- l) To invest the Trust funds from time to time, in such securities and in such manner, as may be prescribed under section 13(5) of the Income Tax Act, 1961 for the time being in force and as amended from time to time, and to realize, invest, vary and alter the same from time to time, subject to however, to the conditions that the funds so invested shall not come within the ambit of section 13(1) of the Income Tax Act, 1961.
- m) To receive, collect or realise or cause collection or realization of all accrued interest, dividends, bonus or premium that accrue or become due of all or any stock, funds, securities, shares, debentures and alike, in which the trust funds have been invested.
- n) To sign and verify all pleadings, memorandum of appeal, petitions and applications of all kinds, to compromise, abandon or refer for arbitration, the whole or any part of the claim or against the Trust, to engage Legal Adviser and to take all other necessary steps to effectively, adequately and assiduously safe guard the interests of the Trust.

- o) To borrow for the purpose of and for the benefit of the Trust for more effectively carrying out the objects of the Trust, whether from the bankers of the Trust or any other legal means, under such terms and conditions as they may agree upon from time to time, provided however the Trustees, beforehand, unanimously agree on such a borrowing of the terms to be specified, and authorizing any two or more Trustees to execute such relevant documents, as may be necessary in connection therein.
- p) To open and maintain a Bank account or accounts of the Trust in any schedule Bank or Co-Op Bank of their choice in the name of the Trust and such account shall be jointly operated by the president and Managing Trustee or be operated by such other person, duly authorised by the Board of Trustees from time to time.
- q) To do all the foregoing acts and other acts, deeds, matters and things, which may be deemed necessary for carrying out and/or fulfilling all or any other objects of this Trust or its administration.
- r) To carry any other activity which is incidental to the activities of the Trust.
- s) The power enumerated above shall be exercised by the Author Trustees or the Board of Trustees on their Attorney as the case may be subject to their satisfying the conditions laid down under section 11,13,12A and 13 of the Income Tax Act, 1961 as amended from time to time, so that the income of the Trust will be exempted from Income Tax, every assessment year and the donations made to it by the General Public are recognised for deduction under section 80 G of the Income Tax Act 1961 for the time being in force.

After deducting the cost, charges and expenses, incurred by the Trustee's as aforesaid, out of the total gross income received by them from the Trust-Property, the balance, that is the net income, will be utilized for the objects of the Trust as decided by the Board of Trustees.

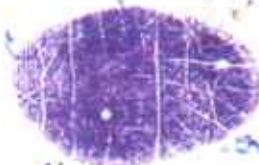

15. POWER AND DUTIES OF THE EXECUTIVE TRUSTEE:-

The EXECUTIVE TRUSTEE, shall have such power as may be conferred upon him by the Board of Trustees from time to time and shall carry out the duties as are assigned to his specifically by the Board of Trustees and generally to do all such duties to assist the President and Managing Trustee in carrying out their duties.

17. REMUNERATION OF TRUSTEES:-

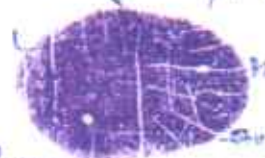
